- Stewardship Report
 October 31, 2009

Plus leniency on requirements for the following programs that will be delayed for 1 year:

- Growth and Yield program
- Forest Inventory Program

Without Footner Forest Products Ltd. on landbase it impacts ability to push forward with these items.

Wait to see what happens with Footner Forest Products.

John T. asked what is being done with wood left in bush?

Brad A. stated that Footner Forest Products are in discussions with ASRD in Edmonton.

Marilee T. asked why can't Tolko just proceed with DFMP?

There is too much financial burden and Tolko need their joint partner to work out the details.

Jeremy stated that Tolko is requesting that compartments be opened in the absence of a new DFMP Landbase and Yield Curves submitted for 2009 Plan.

- Nate interviewed 4 Public members of the PAC (Marilee, Joy, Tom, Aaron)
- Nate interviewed Ted Edwards with ASRD

Positives:

- Excellent field booklets and manuals developed by the Company
- Statement in PAC TOR and letters to First Nations, "aboriginal and treaty rights will not be prejudiced by taking part in company Public Involvement program".
- Good MSDS records at Friesen camp
- Good EMS manual supplements

Opportunities for Improvement:

- ➤ Include PAC approval date for Terms of Reference when manual was reviewed and who was present.
- Revise PAC meeting quorum number
- Send copies of APR and meeting minutes for First Nations to keep informed.
- Provide protocols to operators that may need them. (structure retention and CWD protocols)
- > Train staff better for CSA/SFM orientation.
- Clarify what constitutes soil disturbance in Operational Expectations Booklet.
- Consider adding First Nations protocol agreements
- Keep TFA's at camp
- > Ensure operators know how to and use operational controls.
- > Ensure follow-up with Tailgates.

System Weaknesses:

- Ensure efforts are taken to increase PAC membership.
- ➤ Ensure operators are aware of all things they may be required to do (CSA/ISO).
- > Ensure fueling areas have collision protection.
- ➤ Ensure Public Involvement Plan is created to make sure deficiencies in APR targets are addressed before next operating season.
- Follow-up and create Environmental Incident Reports for ASRD identified environmental incidents.
- Ensure management documents all things reviewed at meeting to meet standard.

Tolko was re-certified for the coming year.
